


UFCW Remembers Carl Huber



Carl C. Huber, former Executive Vice President, UFCW Executive Board member, and Director of the Collective Bargaining and Negotiated Benefits Department, passed away last week.

A native of Scranton, Pa., Huber first joined the union in 1956 while working as a clerk at A&P. He became a shop steward and beginning in 1964, served as an International Representative for the Retail Clerks, one of the UFCW's predecessor unions. He rose to become a Regional Coordinator, Assitant Director, and President of UFCW Local 21 in northern New Jersey.

In 1984, Huber was named Deputy Trustee of UFCW Local 23 in Pittsburgh, Pa. He was elected President of Local 23 in 1986 and served until 1992.

Huber was elected to the union's Executive Board as an International Vice President in 1992, and served as Director of the UFCW's Retail Division. In 1994, Huber was elected Executive Vice President. Huber oversaw organizing and collective bargaining efforts for Regions 1, 2, 4, 6, and 7. He also held various offices with central labor councils and state federations.

"Carl Huber developed strategies and coordinated programs that touched the lives of thousands of UFCW members," said UFCW President Joe Hansen. "With his passing, the UFCW family and all of labor lost a champion for workers rights." **OP**

House of Raeford Warehouse Workers Join Local 204

Warehouse workers at the House of Raeford poultry processing plant in Raeford, N.C., voted overwhelmingly to join with their UFCW brothers and sisters and take charge of their own lives through a voice on the job and a union contract.

Though many workers at House of Raeford were already UFCW members, the warehouse workers were previously not represented by the bargaining unit at the plant. Together, they stuck it out for their right to be included, despite pressure from management. **OP**

UFCW 1564 Grocery Workers Ratify Contract

New Mexico members represented by UFCW Local 1564 have overwhelmingly ratified a four-year agreement with Albertson's by a nearly 100 percent vote.

Workers will see improvement in their health benefits, additional money to their pension funding, and wage increases in each year of the agreement, along with improvements on vacation, holiday, lunch breaks and rest periods. **OP**
