

Warehouse Workers United Calls on Walmart and Suppliers to be Responsible Contractors

Workers all along Walmart's supply chain are standing up for their rights in the workplace, with support from faith leaders, students, union members, and other community supporters. Last week, warehouse workers based in Mira Loma, in California's Inland Empire, staged a lunchtime walk-out to deliver a petition asserting their fundamental rights.

The warehouse workers are working with Change to Win to gain a voice on the job. The workers are some of the most vulnerable members of Walmart's American supply chain, removed from Walmart's legal liability through the use of the subcontractor Schneider Logistics and temp agencies. They are considered temporary or day laborers, despite often working for years in the same warehouse, moving Walmart products. Workers often make less than minimum wage and work 15-16 hour days without adequate breaks as they fulfill daily quotas of moving 100,000 tons of merchandise.

Local 1428's president, Connie Leyva, rallied the crowd who came to cheer on the workers. Workers had already scored an important victory over Schneider Logistics when a court intervened the previous week to prevent the company from terminating workers in retaliation for a wage-theft lawsuit. The action was intended to hold Walmart accountable for the actions of its subcontractors and the conditions of the warehouse workers they employ. With Leyva by their side and a crowd of supporters behind them, the workers delivered their petition to the warehouse boss at Schneider's calling on both the warehouse operator and Walmart to adopt a Responsible Contractor Policy. When management refused to even accept their petition, the workers vowed to come back.

This combination of subcontracting and worker exploitation is profitable both for Walmart and contractors like Schneider's, but highly destructive for workers. By paying low wages and evading labor laws, these warehouse subcontractors continue to exercise a downward pressure in salaries and benefits along the retail supply chain. Today, warehouse workers in Mira Loma see hope in uniting together with the support of UFCW members. **OP**

UFCW Members in Ohio Organize to Stop Anti-Worker Legislation

Although voters in Ohio overwhelmingly repealed a law that would have stripped public sector workers of their right to bargain collectively, anti-worker activists are circulating petitions to put anti-worker legislation on the ballot in Ohio. In order to counter this initiative, UFCW Local 75 and partners from the Ohio Organizing Collaborative held a Valentine's Day Lobby Day at the State Capitol in Columbus.



Along with members of faith based and neighborhood organizations, 71 members of UFCW Local 75 met with 26 Ohio legislators. They talked about the negative effects of anti-worker legislation in their communities and their presence was recognized on the floor of the Ohio Senate by Minority Leader Eric Kearney. All of the groups who participated in the lobby day talked about the need for good jobs and strengthening the middle class.

"We're constantly reminded that politics matter. Who we elect affects us at the bargaining table and at the kitchen table," said UFCW Local 75 President Lennie Wyatt. "It's so important for our members to speak with their legislators and talk about issues that are important to them and their families." **OP**
